4. Electronic bids must be submitted to Shivanath Rural Municipality Office, Baitadi, through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on 2080/11/09 (February 21<sup>st</sup>, 2024). Bids received after this deadline will be rejected.
5. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
6. Shivanath Rural Municipality Office, Sullekhan Baitadi, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.

In case of discrepancy or error in Tender notice, bid document and other document of Construction of various project mentioned above of Shivanath Rural Municipality reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Office.
