- 4. Electronic bids must be submitted to Shivanath Rural Municipality Office, Baitadi, through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 Noon on 2078/10/27 (February 10th, 2022). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2078/10/27 (February 10th, 2022)at the office of Shivanath Rural Municipality Office, Sullekhan, Baitadi. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
- 6.If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
